# MEETING MINUTES



New assembly planning meeting  
Wednesday, June 09, 2010



Meeting began at 7pm.

Sixteen brother knights were present, representing Councils 10010 and 9705.

**First order of business** was to name the assembly. Motions were put forth for "St. Bernadette" and "Saint John Vianney". Based on a vote among the brother knights present, the name is "Saint John Vianney Assembly".

**Second order of business** was to nominate and elect officers.

- Nominations were called for Faithful Navigator naming Joe Wall and Ed Cislo. Based on a vote among the brother knights, Joe Wall was elected Faithful Navigator.

- Nominations were called for Faithful Captain naming Joe Fertitta. Joe Fertitta was elected by acclamation.

- Nominations were called for Faithful Pilot naming Jeff Hicks. Jeff Hicks was elected by acclamation.

- Nominations were called for Faithful Scribe naming Marc Smith. Marc Smith was elected by acclamation.

- Nominations were called for Faithful Admiral naming Ed Cislo. Ed Cislo was elected by acclamation.

- Nominations were called for Faithful Comptroller naming Greg Miles. Greg Miles was elected by acclamation.

- Nominations were called for Faithful Purser naming Colby Ritter. Colby Ritter was elected by acclamation.

- Nominations were called for Faithful Outer Sentinel naming Jim Weller. Jim Weller was elected by acclamation.

- Nominations were called for Faithful Inner Sentinel naming Patrick Nicholson. Patrick Nicholson was elected by acclamation.

- Nominations were called for One Year Trustee naming Harry Lee. Harry Lee was elected by acclamation.

- Nominations were called for Two Year Trustee naming Kent Haggerty. Kent Haggerty was elected by acclamation.

- Nominations were called for Three Year Trustee naming Lenny Sarro. Lenny Sarro was elected by acclamation.

- Nominations were called for Faithful Friar naming Fr. Stephen Gideon. Fr. Gideon was elected by acclamation, pending episcopal approval.

**Third order of business** was to discuss the exemplification for candidates for the new assembly. The exemplification will be Saturday August 14, 2010 at Saint John Vianney Church. The Faithful Navigator elect requested servers and other help needed for the banquet from the Deputy Grand Knight of Council 10010. The DGK agreed to provide any help needed.

**Fourth order of business** was to count form 4 s of transfers and candidates. Thirty are needed to form the new assembly. There were twenty five. Discussion after the count indicated that confidence was high that another five forms would be collected.

**Fifth order of business** was to determine the amount of assembly dues. A motion was made for assembly dues to be \$15, with \$10 dollars going toward assembly upkeep and \$5 going toward the ciborium fund.

**Sixth order of business** was to indicate that the cost to the candidates for the exemplification would be \$70.

**Seventh order of business** was to determine the cost of meal tickets to the banquet. Motions were made for the cost to be \$20 and \$25. A vote was taken that with the majority voting for \$25.
